

## SUPPLEMENTARY PROTOCOL

### of the 44<sup>th</sup> session of the Joint Russian-Norwegian Fisheries Commission

Business meeting in the frame of the Joint Russian-Norwegian Fisheries Commission took place in Moscow on 10<sup>th</sup> of June 2015.

The head of the Russian delegation – V.I. Sokolov, alternate delegate of the Russian Federation within the Joint Russian-Norwegian Fisheries Commission, Deputy Director of the Federal Agency for Fisheries.

The head of the Norwegian delegation – A. Røksund, representative of the Kingdom of Norway within the Joint Russian-Norwegian Fisheries Commission, Deputy of the permanent Deputy Minister for Industry and Fisheries in Norway. Composition of the delegation of both Parties are presented in the Appendix.

In accordance with the article 5.1. of the Protocol of the 44th session of the Joint Russian-Norwegian Fisheries Commission Parties agreed to increase the TAC for haddock in 2015 from 178 500 t to 223 000 t.


