Invitation to Industry Day #3

The NAWSARH project has the pleasure to invite the potential helicopter market, including the potential equipment manufacturers, integrators and support organizations, to the third Industry Day at the project office in Stavanger the 19th - 20th (21th) October 2010.

The helicopter manufacturer / helicopter supply organization is invited to participate with up to six members. The potential equipment manufacturers, integrators and support organizations are invited to participate with up to three members.

The intention with the Industry Day is to give all possible contenders equal information as regards the recent government decision on the concept chosen for the future Norwegian AWSAR-helicopter. This will include the process forwards, key ambitions for the service, goals, major requirements, and finally the overall concept including the planned operational and maintenance bases and number of helicopters.

The NAWSARH project will highlight the effect the major requirements will have on expected helicopters, mission equipment, integration with major systems and support arrangements.

The Industry Day will allow the potential market to question and discuss with the project, either in plenum sessions, or in nominated breakout sessions, issues related to the published concept study material and other relevant acquisition issues.

The market is invited to hold a breakout presentation of recent developments, product enhancement experience and possible solutions.

In order to administer the breakout sessions we will allow helicopter manufacturer / helicopter supply organization a maximum time for presentations and potential questions/ discussions of three hours and the equipment manufacturers, integrators and support organizations a maximum time of one hour. We will arrange the breakout sessions from lunch day one and continue day two and possible day three if required.

The potential companies are requested to pre-book each participant and the most wanted time and duration for breakout sessions. We kindly ask interested parties to respond within 8th October 2010. Each company will be informed on their schedule by 12th October 2010.
