- Complementing discussions on waste management and public services




# What does Municipal Waste Europe do?

- Promoting the public responsibility for waste management.
- Safeguard the interest of municipalities and public entities responsible for policy and operation in the field of waste management
- Gathering and circulation of information
- Organizing exchange of experience amongst members and others
- Raising awareness and opinions, influencing decision makers and to take actions on issues regarding the area as stated in the objective

### Producers responsibilities

- Principle of producer's responsibility
- Based on environmental assessments?
- When cross-sectioning municipal waste two responsibilities
- Risk for parallel infrastructure and double cost
- Risk for unidentified responsibility for the municipalities

### Proposal:

- Full cost coverage by producers
- Fully transparent cost- and operations systems
- Avoid parallel systems, use existing habits and infrastructure



# Producers' responsibility for WEEE

- Full cost coverage for all collecting eee (electric and electronic equipment) as weee, especially when mandatory to do so
- Only if agreement under cost coverage,
  will the municipalities hand over collected weee to producers and include it towards their targets.
- If no agreement for full cost coverage, municipal waste including electrical waste will be handled with full environmental concern. No waste handed over to producers and no statistics towards producers targets.



## Reduce climate change

- Limit emissions of CO2 and greenhouse gases
- Primary waste action for EU-27 in climate aspect is to reduce landfilling and especially of organic waste
- Develop waste management in line with waste hierarchy
- Develop collection infrastructure, concentrating on hazardous and dangerous substances
- Result of waste management must be suited to the needs of the region



## Waste management services

- Municipalities or regions with obligation to ensure waste management services are present for all
- Acting from a responsibility for environment and human health
- There is freedom of choice concerning organizational and financial structure for local and regional waste management responsibility.
- Local and public sector contributes to sustainable waste management services.
- All operators must operate with competence, technical equipment and in line with legislation



# Obligation to provide waste management

- This is a part of Member State responsibility
- It can be delegated by law to municipalities/regions
- It is a service of general interest
- It can be executed through municipal in-house operations
- EU-Concession, public-private partnerships are possible
- "Out-house" operations only after public procurement
- All other cases public procurement
- National legislation define closer!



### Waste management in the future

- Waste management by obligation (ensured by legislation) is essential to public health and environment.
- The public waste management can not be expected to provide services and infrastructure for private sector - including producers. Not without full cost coverage.
- Waste management can not be divided between momentarily profitable actions and all the long-term or unprofitable actions.
- Waste management must be seen as the complete, complex, interactive sector it is.
